**NOTIFICATION**

The Governor, Himachal Pradesh, in exercise of powers vested in him under Rule-15 A of Himachal Pradesh, Jal Shakti Vibhag, Computer Programmer, Class-I (Gazetted) Recruitment and Promotion Rules, 2020 and on the recommendations of Himachal Pradesh Public Service Commission, is pleased to order the appointment of Sh. Effy Raja Naru S/o Sh. Munir Din Naru, Negi Niwas, Near Durga Mandir, Dhalli, District Shimla (H.P.)171012 as Computer Programmer on contract basis for a period of one year on fixed contractual emolument of Rs 15,300/- per month (Minimum of the pay band+ Grade Pay i.e. 10300-34800+5000 Grade Pay) (**Pre-revised**) with immediate effect, in the public interest.

2. The appointment orders will be on provisional basis and subject to the condition that in case character and antecedents of the candidate is found not verified and any false information is given by the candidate in his/her self-declaration, the provisional appointment will be cancelled forthwith and criminal/ legal action will be taken, as a consequence.

3. The appointment to the post of Computer Programmer, Class-I (Gazetted) in the Jal Shakti Vibhag is subject to the following terms and conditions:-

(a) Candidate selected for appointment on contract basis will be initially appointed for one year which shall be extended further subject to satisfaction of work, conduct and performance of such appointee. The service of contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/ conduct of contract appointee is not found satisfactory.

(b) Contract appointee so selected under these rules will not have any right to claim regularization or permanent absorption in the Government job.

(c) Contractual appointee will be entitled for one day's casual leave after putting one month service. However, the contract appointee will also be entitled for 10 days Medical Leave & 5 days' Special Leave. He shall not be entitled for Medical re-imburement and LTC etc. No leave of other kind except above is admissible to the contract appointee.

Provided that the un-availed Casual Leave and Medical Leave can be accumulated upto the Calendar year and will not be carried forward for the next Calendar year.

- (d) Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the contract. However, in exceptional cases where the circumstances for un-authorized absence from duty were beyond his control on medical grounds, such period shall not be excluded while considering his case for regularization but the incumbent shall have to intimate the controlling authority in this regard well in time. However, the contract appointee shall not be entitled for contract amount for this period of absence from duty: Provided that he shall submit the certificate of illness/ fitness issued by the Medical Officer, as per prevailing instructions of the Government.
- (e) Contract appointee who has completed three years tenure at one place of posting will be eligible for transfer on need based basis, wherever required on administrative grounds.
- (f) Contract appointee will be entitled to TA/DA, if required to go on tour in connection with his/ her official duty at the same rate as applicable to regular counterpart officers at the minimum of pay scale.
- (g) Provisions of service Rules like FRSR, Leave Rules, GPF Rules, Pension Rules and Conduct Rules etc. as are applicable in case of regular employee will not be applicable in case of contract appointee.
- (h) The Employee Group Insurance Scheme as well as EPF/GPF will not be applicable to the contract appointee.

4. The Governor, Himachal Pradesh is further pleased to order the posting of Sh. Effy Raja Naru, Computer Programmer Class-I (Gazetted) (on contract basis) in I.T. Cell in the O/o Engineer-in-Chief, Jal Shakti Bhawan, Tutikandi, Shimla-171005 against vacant post, with immediate effect, in the public interest.

5. The candidate is directed to sign the Agreement (**copy enclosed**) immediately and submit the same in the office of undersigned and join thereafter at his respective place of posting as mentioned above within 10 days from the date of issuance of this notification. If for any reasons the candidate is unable or unwilling to accept the appointment, intimation may be sent to this department immediately.
