ORDER

WHEREAS, the transfer orders of some Assistant Engineers (Civil) in Jal Shakti Vibhag were issued vide this Department's notification of even number dated 05th June, 2023.

AND WHEREAS, the posting orders of Sh. Hans Raj Kaushal, Assistant Engineer were not issued and it has been stated that his posting orders will be issued separately. In the meanwhile, Sh. Hans Raj Kaushal (petitioner) had filed Civil Writ Petition No. 3844/2023 against his transfer orders before the Hon'ble High Court of H.P.

AND WHEREAS, the said Civil Writ Petition was listed on 15.06.2023 and the Hon'ble High Court had granted interim stay on the impugned transfer orders qua the petitioner. Thereafter, the said Civil Writ Petition was again listed before the Hon'ble High Court of H.P. on 24.07.2023 and the Hon'ble High Court has directed that the Learned counsel for the petitioner stated that the petitioner has presented afresh representation indicating fresh stations where the petitioner could be adjusted and let the respondents have instructions in that regard.

AND WHEREAS, as per the directions of the Hon'ble High Court of H.P. the petitioner has made representation on 25.07.2023 vide which he has requested to post him either at Jal Shakti Sub Division, Thunag Division, Thunag Distt. Mandi OR Jal Shakti Sub Division, Ladbharol Division, Chauntra Distt. Mandi, against vacant post.

AND WHEREAS, the representation of the petitioner has been considered by the undersigned and it has been decided to post him at Jal Shakti Sub Division, Thunag under Division, Thunag District Mandi against vacant post.
