**ORDER**


WHEREAS, a Show Cause Notice was served upon Shri Rakesh Parashar, Executive Engineer vide this Department's Memorandum of even number dated 12<sup>th</sup> October, 2023 for disobeying the orders of the Government and not joining at his new place of posting i.e. Jal Shakti Division, Killar District Chamba even after a lapse of the stipulated period.

AND WHEREAS, the officer was directed to join at his new place of posting immediately and also to explain his position with regard to whole episode within seven days.

AND WHEREAS, Shri Rakesh Parashar, Executive Engineer in his reply dated 17.10.2023 to the above memorandum has mentioned that he was assigned as Nodal Officer (NGT) & AMRUT and could not join at his new place of posting as he had to submit the progress reports/other information to the higher authorities in pursuance to the directions of worthy Chief Secretary to the Government of Himachal Pradesh. However, the officer has joined his duties at Jal Shakti Division, Killar on 13.10.2023. Besides this, the officer has tendered the apology for the inconvenience caused, if any.

AND WHEREAS, the officer has further been transferred and posted at P&I-I Unit O/o ENC, Jal Shakti Vibhag, Shimla vide this Department's notification dated 18.10.2023.

NOW THEREFORE, after having gone through the reply of the officer and also keeping in view the fact that the officer has been posted somewhere else, it has been decided to drop the show-cause notice served upon the officer. Hence, the show cause notice dated 12<sup>th</sup> October, 2023 served upon Shri Rakesh Parashar, Executive Engineer, is hereby dropped.


