**1. PARA PUMP OPERATOR:-**

**Minimum Qualification:** Matriculation (10<sup>th</sup>) with ITI certificate in the trade of Electrician/Wireman/Diesel mechanic/Pump Mechanic/Motor Mechanic /Pump Operator cum Mechanic/Mechanic (Motor Vehicle)/Pump Operation-cum-Mechanic/Pump Operation and Maintenance from a recognized ITI Or Matriculation (10<sup>th</sup>) with certificate in above cited trades under skill Development Scheme of the Government.

**2. PARA FITTER:-**

No. of Post:- 11 (Eleven)

**Minimum Qualification:** Qualification ; Matriculation (10<sup>th</sup>) with ITI certificate in the trade of Fitter/Plumber from a recognized ITI Or Matriculation(10<sup>th</sup>) with certificate in above cited trade under skill Development Scheme of the Government .

**3. MULTIPURPOSE WORKER:-**

No. of Posts:-36 (Thirty Six)

**Minimum Qualification:** Middle Pass (8<sup>th</sup>) or its equivalent from school duly recognized by the State Government.

Desirable: Knowledge of customs, manners and dialects of Himachal Pradesh.

1. Detailed Marks Sheet of minimum educational qualification i.e Matriculation/Middle.

5. Date of Birth Certificate ( if not mentioned in matriculation certificate)



The Shortlisted candidates will have to undergo a Skill/Physical Test to be communicated separately.
