Approval of annual requirement of G.I. Pipes for the year 2023-24.

The Member Secretary explained that in the previous meeting of Screening Committee held on 16.06.2023, following decision was taken:

"After detailed discussion the Committee approved the requirement totaling 20079 MT (19889MT+190 MT) and authorized the Department to call online tenders through e-procurement for CFY".

As per decision of Screening Committee, the online tender for procurement of 20079 MT G.I. Pipes was called on 21.06.2023 and the technical bids were opened on 17.07.2023. Total sixteen firms participated in the tender. The detail of the participating firms is as under:

After scrutiny of technical bids of all the participating firms by the Technical Scrutiny Committee headed by the Chief Engineer (Shimla Zone), financial bids of all firms which were technically eligible {except M/s Shivam Overseas & M/s Shree Nakoda Pipe Impex Private Limited, which were found ineligible} were recommended for opening. Accordingly financial bids of fourteen eligble firms were opened on 31.07.2023 and found to be in order. The tender case was further recommended for consideration by the Negotiation Committee headed by Engineer-in-Chief (Jal Shakti). The meeting of Negotiation Committee was held on 19.08.2023 in which all five L-1 firms attended the meeting.

As per comparative statement generated online, as well as, financial bids of all 14 participating firms, 5 firms were found L-1 in various dias and detail of L-1 firms is as under:

Quoted rates of all items were found well below the justification prepared keeping in view the rates of raw material i.e. HR Coil from SAIL and Zinc from M/s Hindustan Zinc Limited (HZL) for the month of May, 2023 and considering the consumption, wastage, conversion charges, inspection charges, profit and GST as per past pattern followed in G.I. Pipes procurement.

Further, the Negotiation Committee also compared the rates with the previous year's awarded rates, after allowing price variation of HR Coil & Zinc for the month of May, 2023 (base of instant tender) and further considering the approximate increase of 2% on account of increase of POL charges, Labor charges, Electricity charges & transportation charges etc.

Clarification and financial negotiation with all L-1 firms was done one by one. After great persuasion, rates quoted by L-1 firms for some dias were got reduced. The negotiated rates are based on rate of HR Coils for May, 2023 i.e. Rs. 58300/- PMT and monthly average rate of Zinc for May, 2023 i.e. Rs. 2,45,322/- PMT. The validity of these rates is up to 31.03.2024.

While evaluating the offer/ negotiated rates the Principal Secretary (Jal Shakti Vibhag) desired that in future average month wise raw material rates for last three years should also be placed before the Screening Committee to analyze the market trend.

Member Secretary apprised the committee that Chief Engineer (Shimla Zone) has revised & reduced their annual requirement of G.I. Pipes for the year 2023-24, as under:

Member Secretary also stated that the Annual

Action Plan for Rs. 1274.81 Crore has been approved by Government of India for financial year 2023-24 to implement the Jal Jeevan Mission in the State. Further the budget provision under other heads of Water Supply Sector for current financial year is Rs. 274.00 Crore. The tentative cost of procuring of 19546 MT G.I. Pipes is as under:

Only five firms have quoted lowest rates for different dia of pipes, out of which the maximum quantity has been quoted by one firm and the delivery period of supply of G.I. Pipes is only 60 days. Therefore, it was proposed to offer all the participating firms for matching the negotiated rail head rates, so that, supply orders could be placed to these firms also, as per their manufacturing capacity, as well as, previous supply position for the timely receipt of the pipes.





Additional Controller of Stores informed the committee that Industry Department and HPSEB have adopted "reverse bidding" system for e-procurement made for value more than Rs. 2.00 Crore and similar system can be adopted by Jal Shakti Vibhag for pipe procurement.

Hon'ble Chairman desired that possibility of adopting such system for pipe procurement in Jal Shakti Vibhag through NIC e-procurement module be explored to ensure more competitive rates in future procurement. He also directed that videography should done while dispatch of goods from factory premises, as well as, at the time of receipt at consignee end. Besides, GPS tracking of loaded trucks should be introduced to avoid chance of any pilferage during transit.

After detailed discussion & deliberations, the Committee approved the negotiated rail head rates of G.I. Pipes valid up to 31.03.2024 and authorized Jal Shakti Vibhag to seek consent from all eligible firms for supplying material on L-1 negotiated rail head rates up to 31.03.2024.

Further the committee approved to place the supply orders of 19546 Metric Tonne, as per offer/ manufacturing capacity and previous supply position of the firms.

<u>Finalization of tender of D.I. Pipes and procurement of D.I. Pipes for the year 2023-24.</u>

Member secretary explained that in 1st meeting of Screening Committee meeting held on 16.06.2023, following decision was taken for procurement of D.I. Pipes:

"It was decided that fresh e-tender be invited for the entire quantity i.e. 226687 Rmt. for better participation of bidders and competitive prices".

As per decision of Screening Committee, the online tender for procurement of 226687 Rmt. D.I. Pipes was called on 21.06.2023 and the technical bids were opened on 17.07.2023. Total three firms participated in the tender. The detail of the participating firms is as under:

The technical bids of above firms were scrutinized

by the Technical Committee based on the terms and conditions of the NIT. On perusal of documents uploaded by the firm M/s Jindal Saw Limited, it that the firm was blacklisted by Govt. of Manipur, Public was found Health Engineering Department Manipur vide letter no. CE/PHE3-94/NDB (G)/P-IV/2019/2089 dated 28.09.2022 but the same was withdrawn same Govt. vide letter no. CE/PHE/3-94/NDB (G)/P-IV/2019/2864 dated 16.12.2022. The Deputy Director Legal (JSV) suggested that the order has already been withdrawn by Manipur Government vide order No. CE/PHE/3-94/NDB (G)/P-IV/2019/2864 **Imphal** dated 16.12.2022, Therefater M/s Jindal Saw Limited should be considered. However the Technical committee decided that before processing the tender further, clarification regarding blacklisting of firm M/s Jindal Saw Limited be sought from concerned Manipur Government authorities.

Accordingly the matter was taken up to with Chief Engineer, PHED Govt. of Manipur and vide his office letter no. CE/PHE/DI/2023/1030 Imphal 31st July, 2023, it was informed by Chief Engineer (PHED) Manipur that M/s Jindal Saw limited was blacklisted on 28th September 2022 vide no. CE/PHE/3-94/NDB(G)/P-IV/2019/2089 and the same has withdrawn on 16th December, 2022 vide No. CE/PHE/3-94/NDB(G)/P-IV/2019/2864.

Further, clarification was again sought from PHED Manipur as to whether the blacklisting of M/s Jindal Saw Limited has been withdrawal from the date of blacklisting i.e. 28th September, 2022 or the date

of issue of letter of withdrawn i.e. 16th December 2022. In response, Chief Engineer, PHED Govt. of Manipur intimated that the blacklisting order vide no. CE/PHE/3-94/NDB(G)/P-IV/2019/2089, dated 28th September, 2022 and office memorandum No. CE/PHE/3-94/NDB (G)/P-IV/2019/2123 dated 05th October, 2022 stands withdrawn from the date of inception.

After scrutiny of technical bids of all the participating firms by the Technical Scrutiny Committee headed by the Chief Engineer (Shimla Zone), financial bids of all firms were opened on 11.08.2023 and were found to be in order and the tender case was further recommended for consideration by the Negotiation Committee headed by Engineer-in-Chief (Jal Shakti). The meeting of Negotiation Committee headed by Engineer-in-Chief (JSV) was held on 19.08.2023 in which only two L-1 firms M/s Jindal Saw Limited & M/s Tata Metaliks Limited participated. Third L-1 firm M/s Jai Bala Ji Industries Limited informed through email dated 19.08.2023 that "We have already provided a competitive pricing for the mentioned bid, and our prices are firm and fixed. Therefore we will not be able to offer any further discount on our quoted price. All our quoted prices and term and conditions remain unchanged".

As per online generated comparative statement, as well as, financial bids of all the three participating firms, the detail of L-1 firms is mentioned as under:

The Director General, Supplies & Disposal

Haryana has finalized the rates of D.I. Pipes vide Memo No. 81/HR/RC/E-2/2022-23/532-36 dated 25.04.2023, which are valid up to 24.04.2024. An increase of 2.40% {i.e.1% Inspection Charges + 1.4% HP Civil Supplies Charges} was included in the rates of Haryana for deriving the final rail Head rates for evaluation of the instant tender.

Clarification/negotiation meeting with 2 firms which were present was done one by one and after great persuasion some of the quoted rates were got reduced. The Firm's representatives stressed that that the STA rates as allowed by Jal Shakti Vibhag from rail Head to various destinations are on very lesser side, and the same have not been revised since 2011, in spite of increase in fuel rates & other cost index, and therefore, the quoted rates were competitive.

Further the *Impact of Recent Floods on Roads in*Himachal Pradesh was also raised by the firms for considering, which are reproduced as under:

"Impact of Recent Floods on Roads in Himachal Pradesh: we understand that due to recent and ongoing rain, road infrastructure of the state of Himachal Pradesh has been severely damaged due to which we would be incurring higher freight cost that too in hilly terrain. Whereas the same is not case with Haryana which is predominantly a plain area and road infrastructure has not been impacted by rains".

The Negotiation Committee was of the unanimous view that out of total requirement i.e. 2,26,687 Rmt., the major requirement is 2,07,621 Rmt. for 150mm K-7, which is approximate 90% of total requirement, may be considered in priority.

The tender for procurement of D.I. Pipes could not

be finalized for the last two years due to litigation/Court matters and further, as per the guidelines of Hon'ble National Green Tribunal (NGT), the work of some of the Sewerage Schemes is required to be completed in time bound manner i.e up to March 2024 & 2025. Hence keeping in view the reasons explained by the firms and showing their inability to reduce the offered rates further, the Negotiation Committee recommended awarding the rates of only those Dias which are below the justifications i.e. 100m K-7 & 150mm K-7 only. The dia wise detail is mentioned as under:

Programme HIMCAD & NABARD under which Command Area Development activity in clusters of minor irrigation schemes is being carried out in the shape of piped distribution network.

During the year 2023-24, there is a budget provision of Rs. 49.00 Crore in Sewerage Sector and further the funds are also available with concerned Divisions for sewerage schemes in deposit Heads as received from Urban Department.

Further the Member Secretary stated that the Screening Committee in its meeting held on 16.6.2023 decided that a high level committee be constituted at State level to screen the requirement received from various zones keeping in view the budget availability and physical targets for the corresponding year, before putting it up to State Level Screening Committee for consideration.

Accordingly the Secretary (Jal Shakti) to the Government of Himachal Pradesh vide notification no. IPH-B(A)9-8/20212-Loose dated 19.07.2023 & 02.09.2023, constituted a State Level Pre-Screening Committee for purchase of pipes in Jal Shakti Vibhag.

However due to paucity of time, the additional requirement could not be placed before the Committee.

After consideration and discussion. the committee approved that additional requirement of GI Pipes (1796 Metric Tonne), D.I. Pipes (6360 Metric Tonne) and authorize to department to place supply orders as per decision taken above in respect of Item No-1 & 2.

Further the committee approved the additional requirement of HDPE Pipes of 101170 Rmt and authorized Department to procure 82,265 Rmt HDPE Pipes borne on HPCOS Rate Contract. The balance quantity of

18,905 Rmt, which is not presently available on rate contract, shall be procured on finalization of new rate contract.

Additional Item No.-II: Request of firm M/s Vishal Pipes Limited regarding allowing price variation in extended delivery period against supply order dated 27.01.2017.

The Member Secretary explained that the firm M/s Vishal Pipes Limited has again represented vide letter no. VPL/MKTG/IPH-GI Pipes/2022-23: 191 dated 25.02.2023 & VPL/MKTG/IPH-GI Pipes/2023-24- 055 dated 17.08.2023 regarding allowing price variation (increase) for extended delivery period against supply order no. 27059-27120 (457 MT for Excise Duty Non Exempt Category) & 27121-179 (1771 MT for Excised Duty Exempted Category) placed on 27.01.2017.

The firm has explained that the entire ordered material against above mentioned two supply orders placed on 27.01.2017 was manufactured and inspected by inspection agencies on 11.02.2017 & 12.03.2017 and 14.03.2017& 15.03.2017. The inspected material was ready for dispatch within the stipulated delivery period (28.03.2017) but was dispatched in the end of April 2017 due to delay in the receipt of correct Excise Duty Exemption Certificates from some consignees.

The firm M/s Vishal Pipes Limited had represented in the matter several times and the same was also put up before Screening Committee time & again. After consideration, the Screening Committee in it's meeting held on 23.02.2022, allowed the price variation for the month of April 2017 on 237 MT which was delayed due to non-receipt of correct excise exemption certificate within the delivery period.

The firm M/s Vishal Pipes Limited has again stated that in addition to 237 MT GI Pipes {which Excise Exemption Certificate received after delivery period}, the clearance for Excise

On perusal of record received a/w above representation,

it has been found that out of total 613 Metric Tonne G.I. Pipes, the Superintendent, Central Excise, Range-23, Sikandrabad had given approval of clearance for 363 Metric Tonne (Sr. No. 1 to 4), after the delivery period i.e. 28.03.2017 and for rest of material i.e. 250 Metric Tonne G.I. Pipes, the clearance had given well before the delivery period.

This delay is attributable to late clearance of correct excise exemption certificates from Excise Department and as per the inspection notes, the material was manufactured by the firms in February & March 2017. The rates of HR Coil & Zinc had increased subsequently after finalization of tender (August 2016) and during the month of February 2017 & March 2017 there was an increase of HR Coil & Zinc is about RS. 11000/- MT in comparison to rates during negotiation August, 2016 which was incorporated in supply orders dated 27.01.2017 with the condition of price variation. The detail is as under:

In view of above, it is proposed that the price variation for the month of April 2017, for only 363 MT amounting to Rs.26,69,865/- instead of 613 MT be allowed in favour of the firm M/s Vishal Pipes Limited.

After detailed discussion the committee approved the proposal of department and allowed the price variation for the month of April 2017 on 363 MT G.I. Pipes in which the delay was attributable to late clearance of correct excise exemption certificates from Excise Department subject to condition that an undertaking would be submitted by the firm stating that this is the final settlement and nothing extra would be claimed by the firm in future in respect of these supply orders. Undertaking in the shape of affidavit shall be taken from the firm before release of the same.

Additional Item No. III: Extension in delivery period without price escalation against supply orders dated 20.07.2022 & 02.08.2022 in favour of firm M/s Swastik Pipes Limited.

The Member Secretary explained that the firm M/s Swastik Pipes Limited has again represented in the matter vide their letter no. SPL/Jal Shakti Department Shimla/23-24/10 dated 04.09.2023 regarding extension of delivery period against supply orders dated 20.07.2022 & 02.08.2022. The detailed reasons attributable to delay in supplies of ordered pipe by firm are quoted as under:

- The shade of Galvanizing Plant was damaged due to heavy Rain, the photos and survey reports are enclosed and its cover under Force-majeure Clause.
- Shortage of raw material with SAIL due to JJM Program implemented in all over India for smaller dias i.e. 15, 20, 25 & 32mm dia.
- Shortage /non- availability of Trucks under Himachal Pradesh in remote areas.
- The supply orders were placed within a month of supply orders placed on 20.07.2022, 02.08.2022, as we have another commitment with other states in JJM Schemes.

The matter was put-up before the Screening Committee in its meeting held on 16.06.2023 and after detailed discussion the Committee did not agree to the request being devoid of merit.

The firm vide representation dated 04.09.2023 enclosed copies of letter pertaining to report of the Insurance Company/Assessor Agency to substantiate the claim regarding damages to roof structure of shed of galvanization Unit-I sustained on 05.08.2023 (Reference No. DL/TAG/7403/LOR dated 12.08.2023 of Team Insurance Surveyors and Loss Assessors LLP New Delhi). The firm also enclosed copy of certificate issued by Peputy Commissioner (Industries), District Industries Promotion and Enterprises Development Centre Mathura regarding damage to GI Unit-1 and subsequent delay in production & supply of material (Reference No. 3198 dated 22.10.2022).

The firm M/s Swastik Pipes Limited has again claimed that the delay was on account of situation beyond the control and is covered under Force Majeure Clause No. 20 (i) in the tender. The same is reproduced as under:

e le my

- "20. The time and date of dispatch stipulated in the said schedule shall be deemed to be the essence of the contract and if the firm fails to dispatch any consignment within the period prescribed for such dispatch, then without prejudice to its rights otherwise the firm shall agree to pay liquidated damages for non-supply/delayed supply. The onus of levy of liquidated damages shall vest with HP State Civil Supplies Corporation Limited these damages shall be imposed @ of 1% per week subject to a maximum of 10%. However, provision of extension in delivery period in rare circumstances as authorized to Principal Secretary and Engineerin-Chief shall stay as per his discretion and all above said penal action shall follow only after when extension period is exhausted/extension in time period is denied by the said office. After that the penalty shall begin to be levied as above. If the firm still fails to supply the ordered pipe, then L-2 firms shall be awarded with the order at L-1 rates, in case of its refusal L-3 firms shall be invited to execute the order on L-1 rates.
 - i) The department reserves the right to withhold 5% payment for post-delivery testing. The delivery period shall be subjected to force-majeure clause, particularly blockade of roads due to climatic conditions.

The Office Memorandum issued by Govt. of India Ministry of Finance, Department of Expenditure, Procure Policy Division vide No. F.18/4/2020-PPD dated 19th February 2020, The Force Majeure Clause (FMC) is reproduced as under:

"A Force Majeure (FM) means extraordinary events or circumstance beyond human control such as an even described as an act of God (like a natural calamity) or events such as a war, strike, riots, crimes (nut not including negligence or wrong-doing, predictable/ seasonal rain and any other events specifically included in the clause). An FM clause in the contract frees both parties from contractual liability or obligation when prevented by such events from fulfilling their. obligations under the contract. An FM clause does not excuse a party's non-performance entirely, but only suspends it for the duration of the FM. The firm has to give notice of FM as soon as it occurs and it cannot be claimed ex-post facto. There may be a FM situation affecting the purchase organization only. In such a situation, the purchase organization is to communicate with the supplier along similar lines as above of further under this contract is prevented or delayed by any reasons of FM for a period exceeding 90 (Ninety) days, ether party may at its option terminate the contract without any financial repercussion on either side".

The committee discussed the matter in detail and observed that the delay in supply is quite substantial and has resulted in delay in execution of works in various affected divisions. The delay in supply of material cannot be contributed to Force Majeure and covered under clause of the agreement. Although recovery of liquidated damages alone cannot compensate for the loss suffered by the department, yet taking a lenient view, the Committee decided to reject the claim without taking any further action.

Further the Chairman directed that in future before putting matter in Screening Committee, the same may be put up for Pre-Screening Committee for its recommendation.

Meeting ended with a vote of thanks to and from the Chair.
