Sealed item rate tenders on form No. 6 & 8 are hereby invited for and on behalf of the Governor of HP by the Executive Engineer, I&PH Division, Bilaspur for the following works from the approved and eligible contractors enlisted in I&PH Department so as to reach in his office on or before 27.1.2012 up to 3.00 PM and will be opened on the same day at 3.30 PM in the presence of intending contractors or their authorized representatives. The tender forms can be had from this office against cash payment (non refundable) up to 4.00 PM on 24.1.2012.

The firm / contractors who download the tender form from the website shall deposit the cost of tender form along with other eligibility criteria in a separate sealed cover up to 11.00 AM on the day of opening of tender's i.e 27.1.2012 and can collect the requisite form, from the office after scrutiny of their application. The rates in the tender form will be filled in words and in figures failing, which the tender will be rejected.

The Earnest money in the shape of National Saving Certificate / FDR/Time Deposit Accounts / Saving account in any of the Post office in Himachal Pradesh duly pledged in favour of the XEN must be accompanied with each tender. Conditional tenders and the tenders received without earnest money will summarily be rejected. The tenderer may bring the latest income tax clearance certificate and registration with HP sale tax department with latest clearance certificate and renewal of enlistment. The Executive Engineer reserves the right to reject any tender without assigning any reason. The offer of the tender will be kept open for 120 days. **Note: Other conditions are as per schedule of quantity.**
