

Proceedings of the meeting held on 06.08.2018 under the Chairmanship of the Superintending Engineer, IPH Circle, Dharamshala to review the decision taken in the Review Meeting on various issues of I&PH Department held on 28.07.2018.

At the outset, Superintending Engineer, IPH Circle, Dharamshala welcomed all the participants. Before initiating discussion on the agenda items, the Chairman apprised to all the officers/ officials regarding priorities of the Government as discussed in the review meeting held on 28.07.2018 under the chairmanship of the Secretary (IPH) to the Government of Himachal Pradesh in Room No. 222, Armsdale Building, HP Secretariat, Shimla.

Thereafter, the agenda items were taken up for discussion as under;-

1. Implementation/ status report on C.M. Announcements.

i) **E-mail received through the Hon'ble C.M.**


9. HIMCAD.
