**ORDER**

WHEREAS Sh Rajinder Singh, Executive Engineer, IPH Division Fatehpur, Distt Kangra was transferred to IPH Zone Dharamshala, Distt Kangra vide this department notification No. IPH (A)-B(6)-1/2018-loose dated 09.07.2018;

WHEREAS, against the above orders, he filed OA No. 4030 of 2018 titled as Sh. Rajinder Singh, Executive Engineer Vs State of HP and Ors before the Hon'ble HP Administrative Tribunal Shimla and Hon'ble Tribunal disposed of the matter on 13.07.2018 with the direction reproduced as under :-

*"...In the facts and circumstances of the case, the original application is disposed of with a direction that the applicant may file a comprehensive representation for cancellation of his transfer or suitable adjustment to 1<sup>st</sup> respondent through the Principal Secretary (I&PH) to the Govt. of HP within five days. 1<sup>st</sup> respondent shall decide the same after affording an opportunity of being heard to the applicant as well as private respondent No. 2, if so desired, by 31<sup>st</sup> July, 2018. The further action, pursuant to notification dated 9<sup>th</sup> July, 2018, Annexure A-3, shall stand stayed deferred till decision of the representation.*


*5. Pending miscellaneous application(s), if any, also stands disposed of..."*

WHEREAS in pursuance to the direction of Hon'ble Tribunal, Shimla, the applicant submitted representation dated nil;

WHEREAS the applicant as well as respondent No. 2 i.e. Er. Anil Puri, Executive Engineer were given an opportunity to be heard in person on 28.07.2018 at 1.00 PM. During the personal hearing, the applicant intimated that his daughter is studying in school, while his wife is working at distant place. Hence, his transfer orders from IPH Division Fatehpur to IPH Zone Dharamshala may be cancelled.

WHEREAS, I have gone through the relevant record of the case in detail and after taking lenient view and adverse family circumstances of the applicant, it was felt that he can be adjusted at the o/o ENC (Project) Fatehpur against vacant post.

Now, therefore, after considering the matter, Sh Rajinder Singh, Executive Engineer, IPH Division Fatehpur, Distt Kangra, who is under orders of transfer to IPH Zone Dharamshala, is hereby adjusted in the o/o ENC (Project), Fatehpur against vacant post.
