At the outset, Member Secretary welcomed the chairman and the members of the committee to the meeting. Before initiating item wise discussion, the Chairman desired to know the status of the decisions taken in the last meeting and follow up action thereof. It was informed by the Member Secretary that the 1st meeting of Technical Committee for the year 2019-20 was held on 08-07-2019.
